

## Shared Accountability Units (SAUs)

## Graduation Rates: Shared Accountability Units

Shared Accountability Units (SAUs): Students and their graduation outcomes are weighted based on the length of time they were enrolled in a given school during the graduation cohort.

- All schools serving 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, and/or 12<sup>th</sup> grade students are included. Schools serving only 9<sup>th</sup> graders, for example, are accountable for their proportional contribution to graduation rates
- Enrollment in quarterly reporting periods is used as a proxy for length of time a student was enrolled in a given school/location
- The school at which the student was enrolled at the end of the reporting period is awarded that reporting period for the graduation rate calculation
- Numerator for the graduation rate calculation: The total number of reporting periods during which students were enrolled at a specific school; <u>Includes graduates only</u>
- **Denominator:** The total number of reporting periods during which students included in the graduation rate were enrolled at a specific school; <u>Includes both graduates and non-graduates</u>
  - ✓ 4-year graduation cohorts can be enrolled in a maximum of 16 reporting periods
  - ✓ 5-year graduation cohorts can be enrolled in a maximum of 20 reporting periods
  - √ 6-year graduation cohorts can be enrolled in a maximum of 24 reporting periods

#### **Cohort Establishment**

#### Students Included in the Cohort

- A. First time 9<sup>th</sup> graders in the first of the four years. Student must meet both conditions:
  - A. Present in one of the PED's 4 enrollment windows as a 9th grader (40D, 80D, 120D, or EOY)
  - B. NOT present in any PED enrollment snapshot as a 9<sup>th</sup> grader in any prior year (40D, 80D, 120D, or EOY)
- B. Transfers In: Students new to public schools in subsequent 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> grade years. Entering students must meet both conditions (1, and 2 or 3 or 4):
  - A. Student appears for the first time statewide in grades 10,
    - 11, or 12 AND
  - B. Must enter as 10th grader in year 2 of the cohort span (40D, 80D, 120D, or EOY) OR
  - C. Must enter as 11th grader in year 3 of the cohort span (40D, 80D, 120D, or EOY) OR
  - D. Must enter as 12th grader in year 4 of the cohort span (40D, 80D, 120D, or EOY)
- C. Students who meet conditions A or B must have a minimum of 2 consecutive snapshots (one semester) in New Mexico public schools.

#### Students NOT Included in the Cohort

- A. Students are excused from the cohort who enter public education any time during or after the 9th grade and are misclassified at entry. Written documentation must be kept at the district, and reclassification must occur within one snapshot of the entry snapshot.
  - Example: A student enters from out-of-state and parents declare the student to be in the 10th grade. Transcripts which arrive later show the student qualifies to be a 9th grader. This correction must occur within the first two snapshot windows for that student in order to reassign the student to a different cohort.
  - Reclassified students must be reassigned to the appropriate cohort. In the
    previous example, the student would be an entering 9<sup>th</sup> grader in the subsequent
    cohort.
- B. Students do not belong to any cohort if they were pre-enrolled as a first-time 9<sup>th</sup> grader at the beginning of the cohort span but never attended
- C. Students who meet exemption criteria do not belong to any cohort (note that all require written documentation):
  - Deceased
  - 2. Foreign Exchange: Present in the United States on a "J" Visa
  - 3. Transfer-Out: Left to a non-PED school, including an out-of-state, BIE, home, or private school
  - 4. Émigré: Left the United States by moving or was deported. Does not include military families on temporary duty, or US students studying abroad as part of an exchange program. These students qualify for Transfer-Out.
- Students who have already counted in a prior cohort as a non-graduate. The exception is that students will count for the current cohort where graduation in the 5<sup>th</sup> or 6<sup>th</sup> year will be acknowledged.
- Returning adult students that are H6 or higher in their re-entry year can be reclassified into a new cohort. For example, a student that dropped out during their H3 year (typically junior) and returns four years later is now an H7 based on their original cohort. This student has passed all opportunities to count as a graduate in their 4-year, 5-year, or 6-year rates and re-enters as a member of a new cohort based on their grade at readmission.

## Documentation of Student Mobility

- A. Districts are required to maintain written evidence of students who TRANSFER OUT, LEAVE THE U.S., or become DECEASED; definitions and requirements for written documentation are appended
- B. Districts will be audited at random by the State to verify documentation
- C. Written evidence must be kept for 5 years after the student's cohort year expires

Exit Out	Student exited to a school that does not grant state recognized standard diplomas, such as a vocational certification program, or GED. The school may be in-state or out-of-state.	Telephone conversation Email 2
Status Unknown	Student dropped out of school for work, military, or other reasons. Any student with unknown graduation status defaults to "dropout" status.	(No documentation necessary)
Completer	A student that completed all course requirements but did not pass all parts of the high school exit exam.	Results from NMHSCE or HSGA Course completion
Graduated	A student that completed all graduation requirements, and received a standard diploma, but was not reported to the State as a graduate in any snapshot.	Standard diploma <sup>3</sup> Other evidence of degree award

<sup>&</sup>lt;sup>3</sup> A New Mexico Standard diploma does not include GED, or Certificate of Completion. It does include students with disabilities completing requirements for a Standard Diploma as defined in NMAC 6.30.2.10, Section J (Career and Ability Pathways)

Note: Graduation rates are a lagging indicator so students who complete graduation requirements over the summer can be included. As such, 2021-22 graduation rates are reported for 2023 VISTAS.

## Shared Accountability Units Example

- Juan was enrolled as a freshman at Thrive Academy at the beginning of the 2018-19 school year. His father was deployed to a military base in Texas in November of his sophomore year. Juan contributes 5 of 11 total reporting periods, or SAUs, to Thrive Academy's graduation rate.
- Juan attended school in Texas until his family returned to New Mexico in February of his junior year.
   Enrollment during Juan's schooling in Texas contributes to neither the numerator nor denominator of the graduation rate calculation.
- Juan graduated from Riverwalk High school at the end of the 2021-22 school year. Juan contributes 6
  of 11 total SAUs to Riverwalk's graduation rate.

#### **Graduation Rate Calculation**

Note: Graduation rates are a lagging indicator to include students who complete graduation requirements over the summer

#### Definition of a New Mexico Graduate

- A. Student must receive a Standard Diploma, which includes the Career and Ability pathways.
- B. All requirements for the diploma, including successful completion of the all parts of the exit examination, must be met by August 1 of the terminal year of the cohort span.
- C. The student's graduation must be declared during the correct year, either by submission to STARS or by submitting to the online program *High School Cohort* prior to the closing date. Late submissions will not be honored.
- D. Non-Graduates: Students who are *Completers* or *Exit Out* are NOT considered graduates, but are important to capture for legislative mandates and policy decisions:
  - A. <u>Completer</u>: Students who completed course work but did not successfully pass all parts of the exit exam are awarded a Certificate of Completion. These students are eligible to receive a Standard Diploma for up to 5 years after their senior year once they pass all parts of the exit exam.
  - B. <u>Exit Out</u>: Students who exit to a setting that grants a credential other than a Standard Diploma. Typically, these include GED, military, or vocational programs such as auto mechanics. While the school may not know if the student successfully completed these programs, they should record the student's intent to enter and complete.

#### Which Schools Receive a Graduation Rate

- A. Schools with any combination of grades 9 through 12
  - 1. Feeder schools (i.e., 9th grade academy) will receive a rate
  - 2. Alternative high schools will receive a rate
  - 3. Charter and state-supported schools will receive a rate
  - 4. Off-site programs and treatment centers that are not considered schools will not receive a rate
- Schools that were in operation during early years of the cohort but closed prior to the publication year will receive a rate. However, schools that changed name or location during the cohort time span but continue the prior school's heritage will inherit the school's cohort members and receive a rate (i.e., a local charter that transitioned to state-chartered status).
- c. Schools with fewer than 4 student records will not receive a rate
- D. Districts will receive a rate compiled from all students who were ever enrolled in the district
  - 1. District rates include students in locally-authorized charter schools
  - 2. District rates exclude state-authorized charter schools located within their boundaries
  - 3. District rates include students in off-site programs that were not part of a rated school
- E. The State will receive a rate compiled from all students ever enrolled in state public education

#### **Graduation Rates**

- <u>Graduation Rate Definition</u>: The percentage of students who graduated with a New Mexico diploma of excellence within a given graduation cohort
  - 4 Year 2018-19 Cohort, graduating 2021-22;
     composed of students who began ninth-grade in SY 2018-2019
  - 5 Year 2017-18 Cohort, graduating 2021-22; composed of students who began ninth-grade in SY 2017-2018
  - 6 Year 2016-17 Cohort, graduating 2021-22;
     composed of students who began ninth-grade in SY 2016-2017
- Graduation cohorts are defined by the number of years since first enrollment in 9<sup>th</sup> grade and the school year in which the New Mexico diploma of excellence is obtained.

## Graduate Rate Equation

Graduation rates are decimal numbers from 0.00 to 1.00

Graduation rate = Number of SAUs for graduates

Number of SAUs for graduates + Number of SAUs for non-graduates
