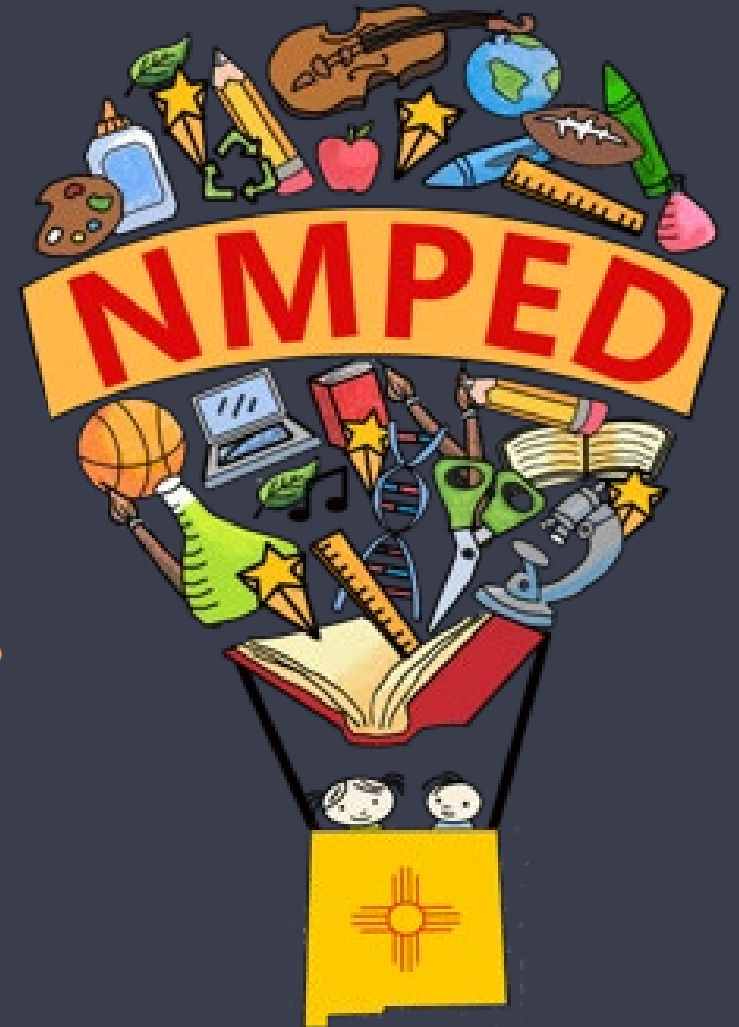

# Regular Attendance (%)

- Definition: Percentage of students attending more than 90% of the school days enrolled
  - Inclusion: Only students enrolled a total of 10 or more school days in the New Mexico Public School system during the school year
  - An eligible student is included in the calculations of regular attendance for all schools and districts where they are enrolled during the school year, with the following caveats:
    - ✓ Locations, including #993 (Hospitalized), #994 (Off-site), and #998 (Homebound), are recoded and reported as #000 (District Office)
    - ✓ Locations, including #992 (Off-site Early Childhood Programs), #997 (Private Schools), and #999 (Home Schools) are excluded
    - ✓ State-supported Districts, including #91 (NM Corrections), #95 (UNM MIMBRES), #97 (Sequoyah), and #99 (Juvenile Justice Centers) are excluded

# Data Sources

- STARS Reports

- The following two attendance reports for SY2023 at the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> reporting periods, otherwise referenced as “40 day”, “80 day”, “120 day”, and “End of Year” (including 8 reports total) are used:

  - ✓ [Summary Attendance No Snapshot Report SY21-22 - Present \(Part 2 of 2\) \(NEW\)](#)
- Variable Names/Measures include:
  - ✓ “STUDENT\_ID” = Student ID
  - ✓ “District\_Code” = LEA code
  - ✓ “Location\_ID” = Location ID
  - ✓ “DAYS\_ENROLLED” = Number of school days enrolled during the reporting period at a given location
  - ✓ “DAYS\_PRESENT” = Number of school days present during the reporting period at a given location

# Formula and Calculations

- Attendance Rate = number of school days present/number of school days enrolled
- *School Attendance Rate:*
  - *Number of days enrolled* – sum of the total number of school days a student is enrolled in a given school/location during the school year
  - *Number of days present* – sum of the total number of school days a student is present in a given school/location during the school year
- *District Attendance Rate:*
  - *Number of days enrolled* – after applicable exclusions (e.g., schools/locations), sum of the total number of school days a student is enrolled at all locations within a given district during the school year
  - *Number of days present* – after applicable exclusions (e.g., schools/locations), sum of the total number of school days a student is present at all locations within a given district during the school year
- *State Attendance Rate:*
  - *Number of days enrolled* – after applicable exclusions (e.g., schools/locations and districts), sum of the total number of school days a student is enrolled at all locations within the New Mexico Public School system during the school year
  - *Number of days present* – after applicable exclusions (e.g., schools/locations and districts), sum of the total number of school days a student is present at all locations within the New Mexico Public School system during the school year

# Business Rules

- If a student's attendance records were not reported in STARS during the school year, or if the sum of the total number of days enrolled is less than 10 for all locations, the student is ineligible for inclusion in calculations
- The overall Regular Attendance indicator includes all eligible students, whereas subgroup calculations of Regular Attendance are further limited; they include only the students present in the SY2023 "All Valid Enrollments"
