



Aztec Schools Title II Proposal Application for Site PLC Groups

A process to enable deeper buy-in on district use of Title II funds.

Why engage school PLC groups in how we spend T2 funds?



The in-house application is based on a previous process that Aztec used for a local grant from British Petroleum that has since expired.



In the BP funded Academic Booster Club (ABC) Grant, teachers were invited to request funding for classroom projects that might be difficult to fund through Title funds. **Teachers enjoyed working together to write these proposals!**



In Aztec teachers are organized by grade level or content area in Professional Learning Communities for lesson/unit planning and classroom testing data analysis.



Aztec used our FY2324 Title II SharePoint application to set aside roughly \$24,000 to fund proposals for teacher professional development that align with their site's PLC goals. (Section 7: Retention Incentives/Stipends)

PROPOSAL FORMS MUST HAVE SITE ADMINISTRATOR APPROVAL BEFORE THEY WILL BE CONSIDERED FOR FUNDING

GUIDING PRINCIPLES

- FOCUS ON IMPROVING STUDENT LEARNING
- Projects that support improved teaching practice for an entire PLC grade level or content group
- Professional Development travel completed by June 2024 that aligns to PLC need
- Professional Development course tuition completed by June 2024 that aligns to licensure need
- Professional Development supplies and materials that support PLC wide instructional goals

FUNDING CONSIDERATIONS

- Avoid recurring costs unless you have a recurring funding source
- Due to limited funding each application will be scrutinized in great detail. Please be fiscally responsible and conservative in your request.
- All site-approved proposals will also need to go through a state Title II program approval process. Plan
 accordingly and make requests early.
- In general, proposal costs should be limited to \$150 per individual teacher involved. However, proposals impacting teachers and PLC groups from multiple sites will be given priority and higher funding consideration.
- Proposal will be considered on an as submitted basis while SY2324 district Title 2 funding related to
 this project lasts. Every effort will be made to ensure that projects for each AMSD campus are considered.

APPLICATION PROCESS

Complete the PROPOSAL application electronically. Incomplete applications will not be considered. Completed applications should be emailed to the Associate Superintendent of Instruction and Federal Programs Director, who will also answer any questions about the process as site teams are working on their proposals.

Proposal Submission Process

- The Aztec Title II PLC PD Proposal Review Team, which will be composed of the Superintendent (or designee), District Federal Programs Director, and the Associate Superintendent of Instruction and Federal Programs, reviews all requests and selects potential recipients.
- Proposal purchasing will be done through the district federal programs office, so that state and federal
 funding requirements can be met more efficiently.
- Funds awarded must be expended in the current academic year.
- All purchases made must comply with current AMSD purchasing policies and procedures.
- Approved proposals must present a written summary to the Associate Superintendent of Instruction and Federal Programs after projects have come to fruition. Summaries must:
- Demonstrate project results with regard to staff professional development and student learning
- Provide an overview and examples of project milestones, artifacts, and demonstrated changes to instructional culture in your PLC and benefit to student achievement.
- <u>Additional Information</u>: If an awardee moves to another school, district, and/or grade level it shall be
 the responsibility of the awardee to make arrangements with his or her replacement to continue the project.
 The Associate Superintendent of Instruction must also be notified.

APPLICATION CHECKLIST

Please use this checklist to ensure that your application is complete.

Applications will be denied if one or more of the following conditions have not been met:

- □ Site Administrator's approval (signature on form)
- □ Completed form
- Completely answered questions
- Signed and dated form

Why use an application form to do this? Isn't it easier to allocate \$\$\$ and let the school figure it out?

- Teachers are fond of wishing they could get a grant for a pet project!
- Few remember that existing federal flow-through dollars might fund their ideas, with a bit of help.
- Allocating the funds to the site does give them a measure of ownership.
- However, site allocated funds also put a good deal of burden on site leadership to manage the accounting.
- An application allowed wider ownership of the process; reduces the principals' burden in approval; and documents the process for accounting and RfRs.


