

New Mexico Public Education Commission (PEC)

Governing Body Member Change Notification Instructions

Purpose: To notify the Public Education Commission (PEC) of a change in a member or members of the school's Governing Body. The school may report multiple member resignations/removals and designations on the same form.

Submission Deadline: Changes to the Governing Body membership do not require prior approval of the PEC; however, notice must be received within 30 calendar days of the change. Vacancies must be filled within 45 days; one 30-day extension may be requested.

Notifications completed 14 days prior to the next PEC meeting will be placed on the next agenda. Notifications of this type are typically placed on the consent agenda; however, any notification may be removed from the consent agenda and moved to the regular agenda for full discussion and possible action by the PEC.

Meeting minutes of the governing board of the school and the PEC will serve as an amendment to, or compliance with, the charter contract regarding this membership change. The documentation will be added to the board of finance documentation on file with CSD.

1. Quorum Call

Governing Council President Carolyn Carlson called the meeting to order at 10:00 am with a Quorum present. Those present were: Channing Concho, Malinda Menke, Carolyn Carlson, Faith Toledo, proposed council member Kendra Toth, Business Manager Mike Vigil II, Principal John Rodarte, Administrative Assistant Courtney Cline, Intern Coordinator Tom Richardson and Media Coordinator Anthony Conforti.

2. Approval of Agenda

Approval of Agenda was made by Channing and seconded by Malinda. Passed unanimously.

3. Approval of Minutes

Approval of the amended October 12, 2023 Minutes was made by Malinda and seconded by Channing. Passed unanimously.

- 4. Committee of the Whole There was no discussion.
- 5. Public Input There was no public input.

6. Reports

Intern Coordinator Report - Tom Richardson reported that the Ice Wolves are interested in taking on another internship. Reports are positive from students and parents who are involved in the filming. Mr. Richardson said that over 50% of seniors have done or are doing internships.

Media Coordinator Report - Anthony Conforti gave an update on the wellness room grant and another possible grant to do a documentary on the project. Mr. Conforti talked about the CNM Film Program, and possibly the new state-sponsored media collaborative, looking at being located at the Railyards.

Principal's Report - Mr. Rodarte sent his principal report ahead of time. He said there have been a lot of good things happening at the school. The wellness grant and documentary are underway. Enrollment is at 151 and has gone down a little since the reporting date. One of our students passed away.

Business Manager's Report - Mike Vigil II of the Vigil Group said he did not have the reports ready as he just received the remaining information to reconcile the books, but they were not

done in time for presentation at the meeting. Mr. Vigil said the school is in good shape with a \$700,000 reserve which is 32% of the school's student budget. There will be a large influx of money for education but what the school needs to consider is what capacity it needs to maintain current staffing, etc.

President Carlson asked for a motion to move Action Items from #8 to #7 on the agenda to permit a vote on proposed new council member, Kendra Toth. If approved, Kendra would be able to participate in the executive session. Malinda made a motion to move Action Items to #7 on the agenda. Seconded by Faith. The motion was approved unanimously.

7. Action Items

Approval of BARs - There were no BARs to approve.

New Council Member Kendra Toth - Channing moved to approve Kendra Toth as a new council member which would fill the spot vacated by outgoing Governing Board Member Mike Trujillo. Malinda seconded, and the motion was approved unanimously.

8. Executive Session to Discuss Pending or Threatened Litigation

A motion was made by Malinda and was seconded by Channing to close the open meeting and go into executive session to discuss pending or threatened ligation pursuant to NMSA 1978 Section 10-15-1.H (7)(2015), which provides an exception to the requirements of the Open Meetings Act for attorney-client privileged communication pertaining to threatened or pending litigation. The motion was approved unanimously. The council moved into executive session at 10:41 am. The council came out of executive session at 11:03 am. Council President said nothing was discussed other than pending litigation.

6. Reports

Principal's Report - Mr. Rodarte sent his principal report ahead of time. Enrollment is 146. The students were disenrolled due to conflicts with parents. One ninth grader enrolled. Mr. Rodarte said that while the school has been awarded grants such as the wellness grant they have not been received. No purchases have been made towards the wellness room. He said school discipline continues to abate. Mr. Rodarte said he wanted to recognize the staff for their continued support of the absent humanities teacher. He recognized Mr. Frampton, the social worker, who was leaving the school. Mr. Rodarte said the school would be looking at contracted social workers. He also said the school should look at the possiblity of hiring a student recruiter/social media coordinator. A new quote came in for the HVAC system of \$30,000 less than the first one. He said there are some classroom changes with a student lounge in the place. He said the green space is ready for the landscaping project. Mr. Rodarte said some of the students interviewed District Attorney Sam Bregman as part of a documentary the students are working on for Rep. Pamela Herndon. He invited the board to the Winter Expo.

Intern Coordinator Report – Tom Richardson said our percentage of students who have completed, or in the process of completing internships hold steady around the 50% mark. He said he was going to meet with the person in charge of the Orphan Sigh

project which takes abandoned signs and turns them into artwork. He suggested the board consider making it a graduation requirement to complete an internship.

Media Coordinator Report - Anthony Conforti gave an update on the wellness room grant and another possible grant to do a documentary on the project. He said he was going to reach out to the city in regards to it's guns and youth initative. Mr. Conforti said he was planning on taking a group of students to the legislature.

Business Manager's Report - Mike Vigil II was present. He said the school is expecting an increase as we do in most years and we do have some funds coming in on the reimbursement basis. He will be working with Mr. Rodarte to make sure all pots of funding are being utilized. His reports reflect a healthy cash balance but the school needs to get more students in the seats. He said as far as the check register it was a pretty even month as far as revenues versus expenditures. The school brought in about \$218,000, and spent about \$215,000, so that equal in and out. There is about \$1.9 million cash balance. He said he could not talk about the audit yet will as soon as it is released by the state.

Principal's Report - Mr. Rodarte's report was short as school was just returning after the winter break. The school's enrollment was 145 with one student not returning from the break. The school was still looking for a middle school humanites teacher and had received several applications. In the meantime, a long-term substitute is in the classroom. Mr. Rodarte said the social worker position is being filled by a contracted position who will be on campus two days a week. He said with the loss of ESSR funds he anticipates a reduction in funds. The ESSR funds were used to fund two positions. He recognized Ms. Chavez and Ms. McDowell for helping in New Mexico History and humanities. He said the heaters went down over the break but were able to be repaired quickly. Landscaping for the greenspace has begun. Plans for graduation will soon be underway.

Intern Coordinator Report – Tom Richardson said his report was going to be short, because school just started up. He talked about a media group that was looking to expand its program where some of our students may be incorporated. He said its name is Public Allies or UNM Service Corps. He said they have done a lot for media literacy programs in Albuquerque.

Media Coordinator Report - Anthony Conforti reported that there was a problem with the wellness room grant. It has been appropriated but not funded. He said a group of students will be going to the legislature during the 30-day session. Mr. Conforti said that the New Mexico Media Arts Collective sounded like it was similar to our school's mission.

Business Manager's Report - Mike Vigil II reported that there has not been a lot of change which is good. We are reconciled through December. So, the end of December is reconciled. We do balance to the general ledger based on the bank statement. Revenues are coming in as we are expecting. One set of new revenues that came in is from Bernalillo County for the purpose of property tax collections, both through the House Bill 33 and Senate Bill 9 allocations. So that's a large portion of what you see as far as the cash flow being a positive as we look through the actual budget. The school is one hundred percent in compliance based on that report. There's no function or fund that is in the negative. And as far as cash flow goes, he said it was a good month as far as cash brought in, and as far as cash going out, with about \$300,000 of money deposited. The school's cash flow is positive through December. The school did enter the month at about 1.1 million in cash in the bank, and then exited with about 1.15 million. Therefore, the cash is still healthy, and the bulk of it does sit in the operational fund, about \$943,000.

He reminded the board that budget wise, we do have to start thinking about formalizing a budget committee, as we get into February, March, April. That way, we can turn around budget. The statutory due date is June twentieth. But the PED can set other deadlines. Other things we have to take into consideration are administrative input, council input and then public input. We need a lot of time to have meetings for all of those requirements, just to do what's right by all stakeholders.
