Dear Dr. Amador and Ms. Skaggs:

Thank you for all of your hard work to support children in New Mexico. As you know, the Public Education Commission voted at its February 2024 meeting to place Alma d'Arte Charter High School on the PEC March 15 agenda. Both the school and the Charter Schools Division will have an opportunity to provide information to the PEC on areas of concern during that meeting. The school will also have the ability to provide any documents that it wishes the PEC to consider at that time as well and may identify to CSD prior to the meeting if there are areas in the 2022-2023 annual report and recent site visit assessment that the school does not believe are accurate.

The PEC follows the intervention protocol process from the PEC rule¹, and, as required by that rule, the PEC is providing you with notice that the school may be placed on the intervention ladder as a possible outcome of meeting. The PEC will be considering the contract provisions, posted on-line². and annual reports related to the school. We understand that you have the 2022-2023 annual report now that will be accepted by the PEC at the March meeting, and the preliminary information from the site visit for this year as well.
