6.10.5 NMAC, School Instructional Time Requirements Guidance and Frequently Asked Questions

Together, statute and rule require a minimum of 1,140 instructional hours and a minimum of 180 instructional days per school year. Up to 60 professional work hours for elementary teachers and 30 professional work hours for secondary teachers may be included in the 1,140 instructional hours. Instructional days for students must be counted in full days (at least 5.5 hours excluding lunch) or half days (at least 3.5 hours excluding lunch). Instructional days cannot exceed 7.5 hours. The rule allows for exemptions to the 180-day requirement for those school districts and charter schools that meet reading, language arts growth, or achievement targets.

This document provides guidance and summarizes questions about <u>6.10.5 NMAC, School</u> <u>Instructional Time Requirements</u>.

1	Question	Where can I find a copy of the final, adopted rule?
	Answer	The rule was published in the <u>New Mexico Register</u> on March 26, 2024.

3	Question	When will calendars be approved?
	Answer	School calendars will be approved by the PED School Budget Bureau in the normal timeline, except for those proposed calendars with fewer than 180 instructional days. Once the exemption data becomes available in June, the department will approve calendars with fewer than 180 instructional days for those school districts and charter schools that qualify. The agency will send budget adjustment request memos to school districts and charter schools that meet exemption requirements. School districts and charter schools that submit multiple calendars but do not meet the exemption requirements will also be notified.

4	4 Question What is the difference between an instructional day and a school day?				
	Answer	Instructional days have between 5.5 and 7.5 instructional hours with students. School days have at least 5.5 hours of instructional hours with students, professional work hours, or a combination of both. All instructional days are school days, but not all school days are instructional days.			
5	Question	If a school calendar has 180 instructional days, does it still have to meet the instructional hour requirements?			
	Answer	Yes. Calendars must include at least 1,140 instructional hours, some of which may be used for teacher professional work hours.			
6	Question	Will schools have to eliminate early release days or lengthen instructional days?			
	Answer	The rule establishes minimum total hour requirements for half days and full days, but daily schedules and course offerings are locally determined, and schedules may be constructed in a variety of combinations to meet the minimum requirements.			

- 7 Question Can an instructional day for part of the student population count toward the 180 instructional day requirement and K-12 Plus?
 - Answer No. Except for the case of graduating seniors, all students are expected to attend an instructional day. If only part of the student population, such as students with a failing grade, is expected to attend, then the day would not count toward K-12 Plus days or toward the minimum 180 instructional day requirement. Similarly, if some students are released after four hours of instruction and some are expected to remain at school for another two hours, this day would count as one-half an instructional day for K-12 Plus and one-half day for the minimum 180 instructional day requirement.

Professional Work Hours

Up to 60 instructional hours per school year for primary grades and up to 30 instructional hours for secondary grades may be used for professional work hours. When calculating a school's total number of instructional hours, time shall not be double-counted as both instructional hours with students and professional work hours.

8	Question	How many professional development hours or days are required?
	Answer	There is no minimum number of professional work hours or days that are required.
9	Question	May professional work hours be included in the minimum 180 instructional days?
	Answer	Up to two days of parent-teacher conferences count toward the minimum 180 instructional days. School calendars must include 180 instructional days, either as full days with a minimum of 5.5 instructional hours with students, or half days with a minimum of 3.5 instructional hours with students. A school district or charter school may decide to include professional work hours for staff on these days before or after the instructional hours with students.
10	Question	Can school calendars include early release for students so teachers may participate in professional development?
	Answer	Yes. See Example 1 in Appendix A.

Charter Schools

<u>The Charter Schools Act</u> requires the PED to waive requirements or rules and provisions of the Public School Code pertaining to the length of school days.

- **11 Question** Does the rule apply to charter schools already operating under the length-of-school-day waiver?
 - **Answer** Yes. The length of school day is the only requirement in the rule that is waived as a non-discretionary waiver. Charter schools still must meet all other requirements of the rule, including the 1,140 instructional hour requirement and the 180 instructional day requirement for the school year.

- 12 Question How is K-12 Plus funding affected by the length of day waiver?
 - **Answer** Only full days that are a minimum of 5.5 hours and half days that are a minimum of 3.5 hours are counted toward K-12 plus funding. See Appendix A for examples.

Early College High Schools

- **13 Question** What qualifies as an early college high school for the minimum 180-day exemption in the rule?
 - Answer Only calendars for schools in which all the students are enrolled in a PED-approved <u>early college high school program</u> will qualify for this exemption.

Performance Criteria for Exemption to the 180-Day Minimum

For each school district or charter school requesting an exemption, the school district or charter school must demonstrate a minimum 95% participation rate on the MSSA-ELA and SAT-ELA assessments. Proficiency is calculated by dividing the sum of all MSSA-ELA and SAT-ELA tests scoring proficient or advanced in the school district or charter school by the number of MSSA-ELA and SAT-ELA tests taken in the school district or charter school. These results are reported to school districts and charter schools in the Cognia Impact Report. Growth will be calculated by subtracting the 2023 proficiency rate from the 2024 proficiency rate.

Exemptions will be granted based on the following four categories:

Category 1. If a school district or charter school has an overall reading, language arts proficiency rate below 45 percent in spring 2024, then the school district or charter school must have demonstrated at least 15 percentage points of growth in reading, language arts achievement.

Category 2. If a school district or charter school has an overall reading, language arts proficiency rate greater than or equal to 45 percent and less than 65 percent in spring

2024, then the school district or charter school must have demonstrated at least 10 percentage points of growth in reading, language arts achievement.

Category 3. If a school district or charter school has an overall reading, language arts proficiency rate greater than or equal to 65 percent and less than 80 percent in spring 2024, then the school district or charter school must have demonstrated at least 8 percentage points of growth in reading, language arts achievement.

Category 4. If a school district or charter school has an overall reading, language arts proficiency rate greater than or equal to 80 percent in spring 2024, then the school district or charter school will be exempt from the 180-day requirement regardless of growth.

Example 1: School District A

- 2024 Reading, language arts achievement: 57 percent
- 2023 Reading, language arts achievement: 44 percent

School District A scored 45 percent or more but less than 65 percent in reading, language arts achievement in 2024 and so must demonstrate at least 10 percentage points of growth to receive an exemption to the 180 instructional day requirement. The school district's growth of 13 percentage points exceeds the minimum 10 percentage points of growth and so all schools within the school district are eligible for the exemption.

Example 2: School District B

- 2024 Reading, language arts achievement: 80 percent
- 2023 Reading, language arts achievement: 86 percent

School District B scored 80 percent or more in reading, language arts achievement in 2024 and so is eligible for an exemption to the 180 instructional-day requirement regardless of growth. All schools in the school district are eligible for the exemption.

Example 3: School District C

- 2024 Reading, language arts achievement: 65 percent
- 2023 Reading, language arts achievement: 58 percent

School District C scored 65 percent or more but less than 80 percent in reading, language arts achievement in 2024 and so must demonstrate at least 8 percentage points of growth to receive an exemption to the 180 instructional day requirement. The school district's growth of 7 percentage points is less than the required 8 percentage points and so no schools within the school district are eligible for the exemption.

- 14 Question Schools do not get the results of spring assessments until May or June. When will school districts and charter schools know if they qualify for an exemption to the 180-day minimum requirement?
 - **Answer** The data to determine eligibility for an exemption will be available in June. School districts and charter schools that seek an exemption must submit calendars that comply with the rule, but may submit secondary calendars that they would adopt if they qualify for the exemption.

15	Question	Do schools with four-day calendars also need to meet the 180-day minimum requirement?
	Answer	Unless a school with a four-day calendar qualifies for the exemption to the 180-instructional-day minimum, the calendar must meet this requirement.
16	Question	If exemption requirements are met, does the rest of the rule apply?
	Answer	Yes. School districts and charter schools that meet proficiency and growth criteria are only exempt from the 180-day minimum requirement. The 1,140 instructional hour minimum is still required.

Snow Days 17 Question How do snow days impact school calendars under the rule? Answer The school calendar must be modified when weather-related closures

reduce the number of instructional days below the minimum 180, or when they reduce the number of instructional hours below the minimum 1,140 hours. The amended calendar must have at least 180 instructional days, at least 1,140 instructional hours, and the same number of K-12 Plus funding days as approved by the department in the original calendar.

However, due to hardship such as severe acts of nature, the Secretary

may waive, on a case-by-case basis, for a current school year, the length of instructional day requirement and the minimum instructional days requirement. A district would then adjust its calendar to ensure it still meets the requirement for a minimum of 1,140 instructional hours.

Ren	Remote Instruction				
18 Question What limits and exceptions are there for remote learning?					
	Answer	With a few exceptions, no more than four instructional days, may be remote learning, and at least half of the remote instructional hours must be synchronous instruction. Exceptions include charter schools in accordance with their charter, or optional instructional programs and schools without attendance boundaries that are created by a school district, which include alternative schools designed to provide primarily remote learning.			
19	Question	Is it considered a remote learning day if some students are at school and some are remote learning?			
	Answer	Yes. If some student groups are at school while other student groups are not expected to come to the school building and are remote learning, that counts as remote learning for purposes of the calendar.			

K-1	K-12 Plus Funding			
20 Question Does the new rule provide for K-12 Plus funding?				
	Answer	Yes. Schools on five-day calendars with 181 to 205 school days and schools on four-day calendars with 156 to 176 school days generate K-12 Plus program units for eligible students in kindergarten through twelfth grade.		

- 21 Question What type of calendar days qualify for K-12 Plus funding?
 - Answer Instructional days and school days qualify for K-12 Plus funding. However, only 60 professional work hours in elementary schools and 30 professional work hours at secondary schools may count toward K-12 plus funding.
- 22 Question How does K-12 Plus funding work?
 - **Answer** The funding for K-12 Plus differs between a four-day school week and a five-day school week.


Schools with four-day calendars receive K-12 Plus funding for days 156 through 175 days.

- The calculation for days 156-165 is: Membership * Unit Value * .012 * number of days
- The calculation for days 166-175 is: Membership * Unit Value * .016 * number of days

Schools with five-day calendars receive K-12 Plus funding for days 181 through 205 days.

- The calculation for days 181-190 is: Membership * Unit Value * .012 * number of days
- The calculation for days 191-205 is: Membership * Unit Value * .016 * number of days

Example 2 In this example, students receive instruction in the morning and the afternoon, and professional development happens after students leave. Instructional Hours Instructional Professional School Day with Students Day Work Hours 5.5 hours count as 1 day toward the 180-day minimum • Full Day 5.5 Hours 2 Hours Full Day · 7.5 hours count toward the 1,140hour minimum, so long as the 30 or 60 hours of maximum professional work time has not been exceeded The whole day may count toward K12 Plus funding, so long as the 30 or 60 hours of maximum professional work time has not been exceeded

In this example, students receive instruction in the morning and the afternoon.

- 5.5 hours count as 1 day toward the 180-day minimum
- 5.5 hours count toward the 1,140hour minimum
- The whole day may count toward K-12 Plus funding
