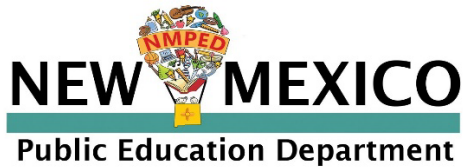

The Cabinet Secretaries of the New Mexico Public Education Department (NMPED) and New Mexico Higher Education Department (NMHED) each appoint individuals to the Dual Credit Council (DCC) as per rule 6.30.7 NMAC. The DCC chair alternates between the departments every two years.

The Council issues recommendations to the Cabinet Secretaries on issues not addressed in the rule. The Council administers an appeals process for Local Education Agencies (LEAs) and Higher Education Institutions (HEIs). The NMPED and NMHED Cabinet Secretaries act jointly upon council recommendations.
