| Preliminary Analysis (Tuesday, October 1) | Preliminary Analysis (Friday, November 1) | The CSD will send each renewal applicant and the PEC a Preliminary Renewal Analysis including a preliminary indication of the recommendation (renewal, non-renewal or renewal with conditions). This analysis will synthesize the strengths and weaknesses of the charter school in relation to the statutory reasons for non-renewal. |
| October 9 PEC worksession PEC letter goes to school (Friday, October 11) | November 6 PEC worksession PEC letter goes to school (Friday, November 8) | PEC to identify schools that may be subject to a condition or non-renewal based on previous information and CSD preliminary renewal analysis. PEC to authorize Chair to send notice letters to school. Note: the application says November 10th, which is a Sunday. |
