

New Mexico Public Education Commission (PEC)

Governing Body Member Change Notification Instructions

Purpose: To notify the Public Education Commission (PEC) of a change in a member or members of the school's Governing Body. The school may report multiple member resignations/removals and designations on the same form.

Submission Deadline: Changes to the Governing Body membership do not require prior approval of the PEC; however, notice must be received within 30 calendar days of the change. Vacancies must be filled within 45 days; one 30-day extension may be requested.

Notifications completed 14 days prior to the next PEC meeting will be placed on the next agenda. Notifications of this type are typically placed on the consent agenda; however, any notification may be removed from the consent agenda and moved to the regular agenda for full discussion and possible action by the PEC.

Meeting minutes of the governing board of the school and the PEC will serve as an amendment to, or compliance with, the charter contract regarding this membership change. The documentation will be added to the board of finance documentation on file with CSD.

Good afternoon, everyone,

As the title reads, I am writing this email to announce my resignation from the Board of Raices del Saber effective 7/31. It was not an easy decision. Many factors, both personal and related to the school, influenced my decision.

I would like to part ways and still provide some insight for my fellow board members to consider. I am not the type to point fingers at others' faults because I know I was still growing as I was chosen to be the Chair of the Board 2 years ago. I would encourage my fellow board members to reflect on the time needed to help the school succeed and what it means to be on the board. It requires time and dedication, things not everyone has, and why it is difficult for boards to find members. There are a lot of concerns that the school faces that require dedicated attention, energy, and effort. At this time, I cannot devote the time necessary to be part of the solution. I am unsure that the school has a foundation to build on. There has been uncertainty with the Xinachtli curriculum; not all staff have been trained in core concepts regarding Xinachtli, issues with state testing or regulations, and oppositional staff. I don't write these things to diminish the school but to shed light on issues that need to be addressed. I'm sure there are more that I may not be aware of, and I hope solutions become the discussion's focus.

I would like to thank all the staff and my fellow board members for their patience as I grew into the role of chair and for our work to get the school rechartered. I went to Santa Fe with as many nerves and excitement as everyone else because I wanted (and still want) the school to succeed. Sometimes, changes in leadership are necessary to help spark change. I hope the school can find its identity with Dr. Giron and the new board members.
