School response: The operational expenditures below show that the majority of expenses are spent in the classroom. Teachers are paid from the direct instruction function. Instructional materials, supplies and curriculum are also purchased using these functions to help students be successful. The

administration costs consist of The Executive Director of the school, Governing Council, Business Managers, and others which help the school stay compliant and run smoothly. The maintenance and operations function of the schools' expenses consist of the building lease, utilities, and maintenance costs to keep the school clean and safe for students. Overall, our operational spending has stayed consistent with most of our spending on students in the classroom.

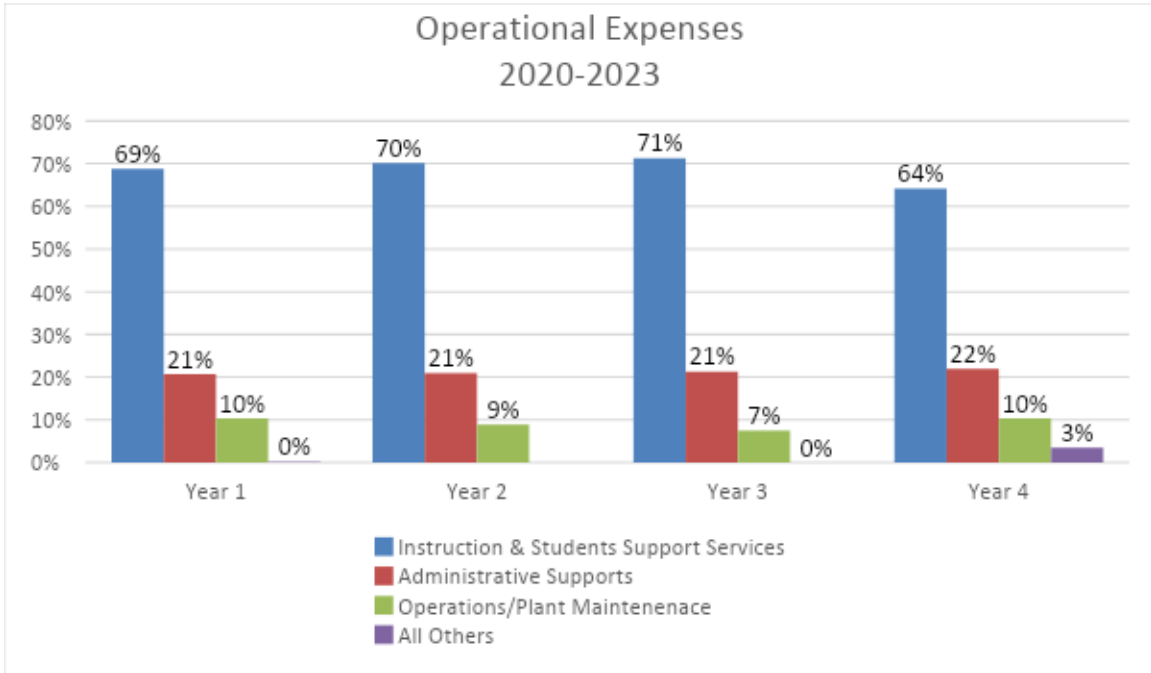

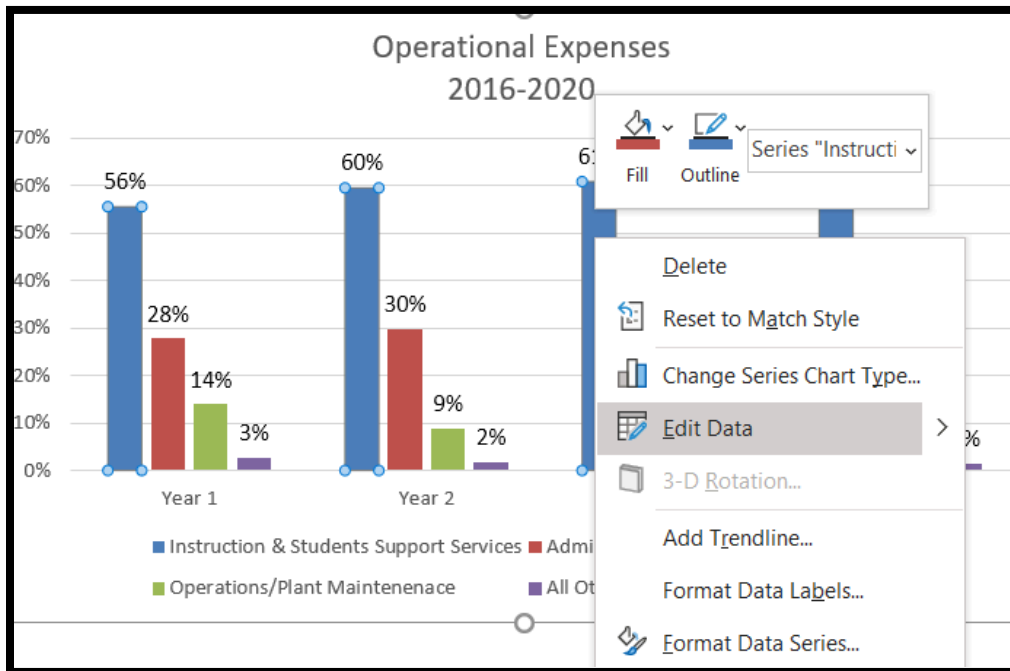
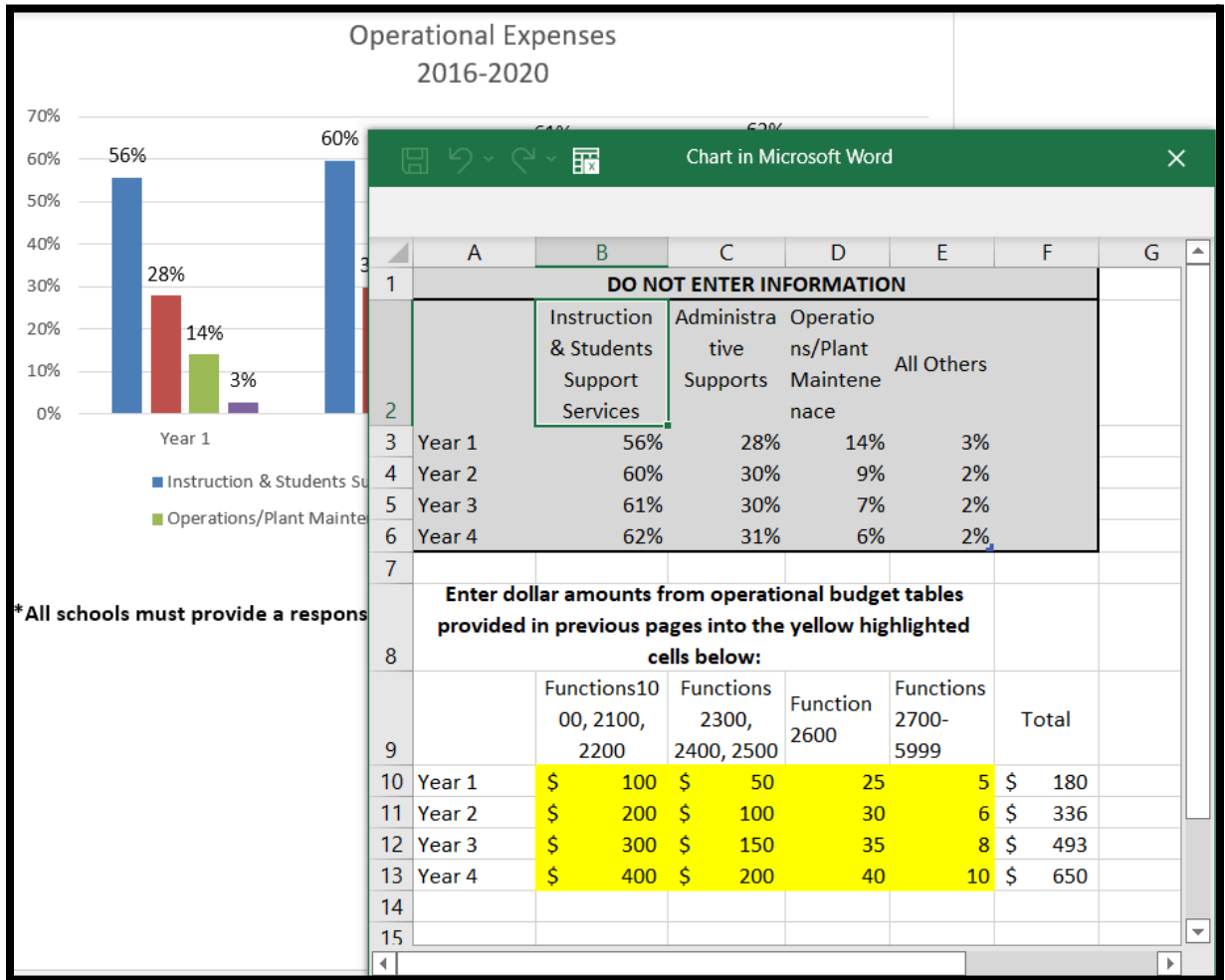


Table that appears when "Edit Data" is selected:
