As you know the application will be on the Public Education Commission's (PEC) agenda the week of December 9, 2024 in Santa Fe, New Mexico. The PEC may renew, renew with conditions, or non-renew the school based on the performance in the charter term and the renewal application. The PEC is following the procedures set forth in the PEC rule, NMAC 6.2.9.16.
