We appreciate the tremendous effort that went into the application. As you know the application will be on the Public Education Commission's (PEC) agenda the week of December 9, 2024 in Santa Fe, New Mexico. The PEC may renew, renew with conditions, or non-renew the school based on the performance in the charter term and the renewal application. The PEC is following the procedures set forth in the PEC rule, NMAC 6.2.9.16.

The Charter School Division (CSD) has provided you with an initial recommendation indicating that the school should be renewed without conditions for a five-year term. They will finalize their recommendation prior to the renewal hearing and include final Vistas data from the New Mexico Public Education Department for 2023-2024 if available. The application looks strong.
