Thank you for submitting your renewal application for Turquoise Trail Community Charter to the Public Education Commission. We appreciate the tremendous effort that went into the application. As you know the application will be on the Public Education Commission's (PEC) agenda the week of December 9, 2024 in Santa Fe, New Mexico.
