2. Discussion and update on Performance Framework templates and status of posting of corrected templates to the PEC website (Second reading)

- a. Corrected Business Rules associated with Performance Framework
 - Reviewed updates to the Performance Framework Business Rules from October 10, 2023.
 - Key Changes
 - Revised technical language and criteria for student growth measurement.
 - Replacement STARS data references with statue data.
 - Discussed concerns about schools defaulting to "no rating" if testing participation is low, with suggestions to amend the business rules to avoid unintended penalties.
 - Next Steps:
 - Voting on these changes at the next PEC meeting.
- b. Status of Corrected Templates
 - Templates will be posted by October 25, 2024.

3. Discussion of the New School Application Process (Second Reading)

- a. Key Points:
 - Added requirements for original thought and citations in applications, use of plagiarism detection tools, and specific plagiarism thresholds.
 - Discussed challenges of compliance language and how to avoid overly punitive measures.
 - Timeline Concerns: Emphasized the importance of informing applicants early if they are disqualified due to plagiarism.
 - Next Steps: Refine the process and discuss whether to make plagiarism checks part of the technical review phase.
- b. Peer Review Process:
 - Added clarity to the role of external reviewers.

4. Discussion of 2025 Calendar:

- 2025 Calendar updated and posted to PEC website.

5. Discussion and status of rollout and budget of items approved:

- a. PEC logo: completion of work from State printing and use of logo
 - Next Steps: Pursue external graphic design and state printing options.
- b. Contract with Naomi DeVeaux for PEC support
 - Contract halted due to budget constraints; Director Chavez has reached out to Deputy Secretary DeBell,
 - Next Step: A scope of work will be needed. A discussion with the Budget Subcommittee would be productive.
 - Vice Chair Carrillo stated moving forward no budget changes should be made without discussion with the PEC Executive Committee and Budget Subcommittee.
- c. Board Acknowledgement awards
 - Some PEC Commissioners have volunteered for this, a subcommittee meeting will need to meet to set up guidelines – what is going to be awarded – what is it going to look like – and what is the criteria for it.

- d. Indicators of Success project, REC contracts and how awards will be determined
 - o Significant funding available for mini grants to support schools, with a cap of \$10K per sub grant.

6. Discussion of charter school challenges and legislation put forward by others

- a. Transportation
 - o Legislative push for first-year transportation funding for charter schools.
 - o Discussed logistical challenges, including bus driver shortages and district negotiations.
 - o Next Steps: Legislative changes to address first-year funding and regulatory adjustments for charter school transportation.
- b. State Charter Lottery Rule
 - o Currently a lottery guidance document but no New Mexico Administrative Code (NMAC)
 - o Commissioners want to promulgate NMAC for state charter schools
 - o The Policy Subcommittee will meet and bring back to the full Commission
 - o Director Chavez will reach out to PED leadership to see if they would like to make an overarching rule for district charters and state charters.
