State Assessment Requirements, 2.c Reporting Requirements and 5.a and b. Financial Reporting and Compliance Accounting Principles concerns on page 11 of the annual report.

# Progress from 2022-23 Notice to 2023-24:

- For goals 1 and 2 the school received "falls far below" rating. The school improved its organizational and financial rating from "Does Not Meet" to "Meets Standard".


# **Educational Program:**

- i. The principal focus of Walatowa High Charter School's academic program is early college preparation, including dual credit coursework. The pre-college focused curriculum also emphasizes the value of the community's (Jemez, Zia, and Jemez Valley Corridor) culture and traditions.
- ii. Students are challenged with advanced courses in core subject areas and enter the dual credit program by their junior year of high school. Walatowa High Charter School maintains strong partnerships with post-secondary institutions to ensure the implementation of our college and career preparation program.
- iii. Walatowa High Charter School implements a community school model that includes the two-generation approach and continuum. As a community school, Walatowa High Charter School is both an educational institution and a center of community life that partners the school with other community resources. The Two-Generation approaches focus on creating opportunities for and addressing needs of both children and the adults in their lives together. Walatowa High Charter School has an integrated focus on academics, youth development, family support, health and social services and community development. The partnerships include:

## **State Accountability System:**

#### Growth

Growth is not available for high school students as data is limited to 11th grade SAT and Assessment of Science Readiness (ASR).




# **High School Graduation**

Dear Mr. Wilkinson and Mr. Sando:

Thank you for all of your hard work to support children in New Mexico. As you know, the Charter School Division (CSD) has completed its annual report for SY 2023-2024 for your school and presented this report along with your responses to the Public Education Commission (PEC) at its January 2025 meeting.

- 1. Notice of Satisfactory Performance. As outlined in New Mexico rule NMAC 6.2.9.12 and 13<sup>26</sup>, the PEC has accepted this annual report. The school will be placed on the PEC agenda for February to discuss how you will remedy the uncorrected unsatisfactory performance, and the PEC may take action under the intervention ladder.

3. New areas of unsatisfactory performance. The PEC identified the following new unsatisfactory performance

-5.e Staffing for Fiscal Management.

The unsatisfactory performance should be corrected by the next annual report. You will work with your staff and board and report your progress to the CSD through the annual site visit and report process to show your progress. If you are successful in improving the performance, CSD will report that in the next annual report, and the concerns will be identified as corrected. If you are not successful (which we hope will not be the case), the school may receive a notice of uncorrected unsatisfactory performance next year which could impact the ultimate renewal of the school.
