Notice from 2022-23 Annual Report: Satisfactory performance

Unsatisfactory terms that need to be addressed from 2022-23 Annual Report: the PEC has identified two areas of unsatisfactory performance related to negative growth for students in reading and math and the student subgroups as listed on pages 6-7 of the annual report; and an organizational concern listed on page 9 of the annual report, indicator 2.b.

Progress from 2022-23 Notice to 2023-24:

• Reading and Math growth: NM Vistas changed the business rules for computing growth from 2022-23 to 2023-24, so comparative growth cannot be obtained. However, the school's reading

growth percentile in 2023-24 was 65th percentile; and the school's math growth percentile in 2023-24 was 57th percentile; percentile ranges from 34-66 represent about a year's growth typical for the academic peer group. Student subgroups percentiles also increased for both reading and math: Reading – 32nd percentile for Hispanic, 67th percentile for Students with Disabilities and 70th percentile for Economically Disadvantaged students. For math – 65th percentile for Hispanic, 57th percentile for Students with Disabilities and 56th percentile for Economically Disadvantage students.

• Indicator 2.b. Accounting Principles: the school earned Does Not Meet again on financial indicator 2.b. in 2023-24. (See PF ratings on page 11.)

Mission: To provide every student the opportunity to develop academically, socially, and physically through quality learning experiences utilizing the Core Knowledge Curriculum.

Educational Program:

5.1.1 At the center of the RRVCS program is the Core Knowledge Curriculum Sequence developed by Dr. E.D. Hirsh, Jr., and discipline system based on the principles of "Love and Logic".

5.1.2 "Love and Logic" fosters a sense of self-discipline and control, imparting to children the self-confidence they need, while respecting all others and treating them with kindness and respect.

5.1.3 "HOWL" (Habits Of Work and Learning) foster self-motivation in the areas of responsibility, respect and perseverance.

5.1.4 Character development is also an integral part of the RRVCS program and is focused on developing positive character traits, which assist all students to grow in relationships with others and to develop citizenship skills that are vital to becoming a contributing member of society.

5.1.5 Core Knowledge provides children with a strong foundation of knowledge in traditional disciplines, while encouraging innovative thinking and multi-disciplinary integration.


5.1.6 RRVCS' instructional model has multi-age, multi-grade classrooms.

5.1.7 Weekly tutoring sessions are offered once a week to all students.

5.1.8 At least five parent and community events are held each school year.




For the school year 2023-24, Red River Valley Charter School received a designation of Spotlight.

Because science is assessed only in grades 5, 8, and 11, schools that do not serve these grades do not have science proficiency data.






Percent Proficient in Math by Subgroup 2023-24






Growth Percentile for All Students (2022-23 to 2023-24)




Reading Growth Percentile by Subgroup (2022-23 to 2023-24)

Mission-Specific Goals

Goal: Red River Valley Charter School (RRVCS) provides opportunities and encourages students to be responsible citizens, to lead by example, to apply knowledge and skills obtained in class to service learning and community leadership. This goal will direct learners into real life settings where the primary motivation is serving. This learning will take place through the experiences and reflections upon what happened during the experience and how it relates to classroom learning through reflection and surveys. Each year, 70% or more of RRVCS students, enrolled on the 40th and 120th day, will participate in at least one service-learning experience per quarter and prior to EOY will complete an age-appropriate self-reflection narrative, and present at student led conferences in the fall, spring, and/or winter.
