# Senate Bill 163 - Tribal Regalia at School Events

Senate Bill (SB) 163, Tribal Regalia at School Events, was signed into law by Governor Lujan Grisham in March. The PED is urging all superintendents and charter school leaders to be proactive in their approach to the implementation of SB 163. Key points of the bill include:

- Public school students enrolled or eligible for enrollment in federally recognized Indian nations, tribes, and pueblos are permitted to wear tribal regalia at graduation ceremonies and events.
- No student may be subjected to discipline, discrimination, or disparate treatment based on race, religion, or culture.
- SB 163 extends these protections to charter schools.

College Board has updated course and exam descriptions for three AP courses - AP Biology, AP Computer Science A, and AP Latin - to be launched in the 2025-26 school year (the changes will not affect the May 2025 exam). AP Classroom resources will begin updating in July and throughout the school year.

AP Computer Science A and AP Latin teachers must reauthorize their courses via the Course Audit by January 31, 2026. To maintain access to AP Classroom for the 2025-26 school year, returning teachers must resubmit by July 1, 2025. Since the AP Biology framework is only being updated, AP Biology teachers are not required to resubmit in the AP Course Audit.
